Delivery- order fulfilment

All items sold on Victoria Perkins Artist's website is subject to availability. Should an item be out of stock, the buyer will be notified accordingly.

Commissioned piece delivery lead-times are subject to the current workload of Victoria Perkins Artist and approximate delivery dates will be communicated to the

buyer accordingly, with regular updates as to a firm delivery date. Victoria Perkins Artist will not be held responsible for delayed commission delivery dates beyond their control, i.e. illness, force majeure.

Processing of orders will take approximately 3-5 days for UK deliveries; delivery will be subject to the mode of courier/parcel service utilised. Delivery should be up to 7 working days, due to the current circumstances (COVID), postal/courier services may be a bit slower, therefore, please allow 10 working days after despatch before notifying Victoria Perkins Artist.

Should your items received be damaged upon arrival, please take photos of the packaging the item was packed in, take detailed photos of the damage to the item, and any other necessary/relevant information that may be prudent for Victoria Perkins Artist to pass onto the parcel service/courier to support the claim. This will need to be sent to victoriaperkinsart@gmail.com within 24 hours of receiving the damaged item.

Returns and Refunds

Victoria Perkins Artist hopes that you are delighted with the items you have received. Should you deem the item is damaged, photos and details will be required and sent to victoriaperkinsart@gmail.com, upon this Victoria Perkins Artist will advise if a refund/repair/replacement is applicable. This information and the returned item must be informed/delivered back to Victoria Perkins Artist within 14 days.

With a valid damage claim, If Victoria Perkins Artist is unable to repair or replace the product within a reasonable time, the customer will be entitled to a full refund upon the prompt return of the product. Victoria Perkins Artist will pay for shipment of repaired or replaced products to the buyer, however the buyer will be responsible for return shipment of the product to Victoria Perkins Artist.

Returns must be informed within 14 days of the date you received the product, however must be contacted first via victoriaperkinsart@gmail.com prior to sending back to Victoria Perkins Artist. Buyers are responsible for the return shipping costs. If the item is not returned in its original condition, the buyer is responsible for any loss in its value. Please note Victoria Perkins Artist will not offer refunds for return request past the 14 days after it was purchased.

Victoria Perkins Artist does not accept cancellations of commissioned orders due to the bespoke nature of the item.
