What data do we collect?

Victoria Perkins Artist collects the following data:

- Contact details
- Activities
- Orders
- Invoices
- Victoria Perkins artist will receive, collect, and store any information you enter on our website or provide us in any other way. In addition, we collect the Internet protocol (IP) address used to connect your computer to the Internet; login; e-mail address; password; computer and connection information and purchase history. We may use software tools to measure and collect session information, including page response times, length of visits to certain pages, page interaction information, and methods used to browse away from the page.

- Personal identification information - We also collect personally identifiable information (including name, email, password, communications); payment details (including credit card information), comments, feedback, product reviews, recommendations, and personal profile.

How do we collect your data?

You directly provide Victoria Perkins Artist with most of the data we collect. We collect data and process data when you:

- When you conduct a transaction on Victoria Perkins Artist's website, as part of the process, we collect personal information you give us such as your name, address and email address. Your personal information will be used for the specific reasons stated in the 'What data do we collect' information only.
- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.

How will we use your data?

Victoria Perkins Artist collects your data so that we can:

- Process your order and manage your account.
- Email you with special offers on other products and services we think you might like.
- To be able to contact our Visitors and Users with general or personalised service-related notices and promotional messages
- To create aggregated statistical data and other aggregated and/or inferred Non-personal Information, which Victoria Perkins Artist may use to provide and improve the respective services
- To provide our users with ongoing customer assistance and technical support
- To comply with any applicable laws and regulations.
- When Victoria Perkins Artist processes your order, it may send your data to, and use the resulting information from, credit reference agencies to prevent fraudulent purchases.

How do we store your data?

Victoria Perkins Artist is hosted on the Wix.com platform. Wix.com provides us with the online platform that allows us to sell our products and services to you. Your data may be stored through Wix.com's data storage, databases and the general Wix.com applications. They store your data on secure servers behind a firewall.

All direct payment gateways offered by Wix.com and used by our company adhere to

the standards set by PCI-DSS as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, MasterCard, American Express and Discover. PCI-DSS requirements help ensure the secure handling of credit card information by our store and its service providers.

Personal information may be stored in data centres located in the United States of America, Ireland, South Korea, Taiwan and Israel. Wix may use other jurisdictions as necessary for the proper delivery of our services and/or as may be required by law. Wix is a global company that respects the laws of the jurisdictions it operates within. The processing of the User Customer Data may take place within the territory of the European Union, Israel or a third country, territory, or one or more specified sectors within that third country, of which, the European Commission has decided that it ensures an adequate level of protection (transfer on the basis of an adequacy decision).

Marketing

Victoria Perkins Artist may send you information about products and services of that we think you might be of interest. We may contact you to notify you regarding your account, to troubleshoot problems with your account, to resolve a dispute, to collect fees or monies owed, to poll your opinions through surveys or questionnaires, to send updates about Victoria Perkins Artist, or as otherwise necessary to contact you to enforce our User Agreement, applicable national laws, and any agreement we may have with you. For these purposes we may contact you via email, telephone, text messages, and postal mail.

What are your data protection rights?

The right to access – You have the right to request Victoria Perkins Artist for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that Victoria Perkins Artist correct any information you believe is inaccurate. You also have the right to request Victoria Perkins Artist to complete the information you believe is incomplete.

The right to erasure – You have the right to request that Victoria Perkins Artist erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Victoria Perkins Artist restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Victoria Perkins Artist's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Victoria Perkins Artist transfer the data that we have collected to another organization, or directly to you, under certain conditions.
